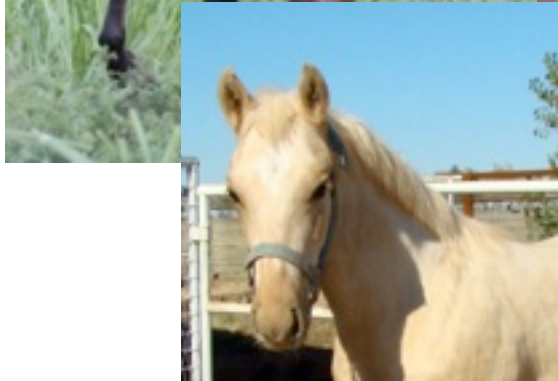



TRANSPORTED COOLED SEMEN CONTRACT

This agreement wherein _____ (mare owner) has engaged Pacific Pleasure Horses (Breeder and Agent for said stallion) for one service to the stallion **COLONEL LENAS BREW** AQHA Reg.No 4217343.

For the mare _____ Breed _____ Reg.No. _____ For the 20__ breeding season for a fee of \$ _____.

This agreement subject to the following terms and conditions:

- 1) A non-refundable Booking of \$200.00 is payable when this contract is signed and returned with a photo copy of the mares papers. This fee is applied to the total breeding fee, the balance \$ _____ of which is payable prior to the shipment of semen.
- 2) There will be no collection fees for utilizing Transported Cooled Semen. We will ship up to three shipments. If the mare fails to settle after the third shipment, your veterinarian will need to contact us before further shipments will be sent. Mare Owner is responsible for all Aloha Air Cargo or Fed Ex Overnight Delivery charges. No counter to counter available at this time.
- 3) Pacific Pleasure Horses uses disposable shipping containers such as BioFlight. We ask that you either purchase the container for \$30 or return it in a timely manner at Mare Owner's expense.
- 4) Pacific Pleasure Horses MUST be notified when the mare comes into heat by the mare owner or representative.
- 5) Pacific Pleasure Horses must be notified prior to 6pm Hawaii Time the day BEFORE semen is to be shipped. SEMEN is available Monday through Saturday assuming proper notification has been received.
- 6) Breeding season begins February 5th 20__ and ends August 31st 20__ at which time all shipments will be discontinued unless prior arrangements have been made.
- 7) Should the stallion die, become unfit for breeding prior to shipping semen the breeder's liability is discharged fully by return of the service fee for inability to breed with cooled semen.
- 8) Pacific Pleasure Horses offers a LIVE foal guarantee. If the mare does not settle, produces a foal that is still born or unable to stand and nurse, breeder is held harmless from all liability and the mare owner is entitled to a free return service the following year for a \$150.00, per collection, fee. Stallion fees are not refundable unless paragraph (7) applies.
- 9) This contract is entered into the STATE OF HAWAII, in the county of KAUAI and will be interpreted and enforced under the laws of that state. If any clause is against the state law then that clause shall be null and void.
- 10) Should either party breach this contract, the breaching party shall pay for the others court costs and attorneys fees related to such breach.
- 11) This contract represents the entire agreement between the parties. No other agreement or promises, verbal or implied are included unless specifically stated in this written contract. When mare owner and Pacific Pleasure Horses (Breeder) sign this contract it will then be binding on both parties, subject to the above terms and conditions.
